This fund is independent from other financial aid opportunities. Applicants are encouraged to apply for tuition support through their schools, parishes, and the diocese where applicable. Awards granted from the *Catholic Diocese of Cleveland School Employee Fund* will have no bearing on eligibility for other financial aid opportunities, though priority consideration may be given for families owing higher percentages of tuition. The OCE holds the right to use secondary factors, such as years of service, to make award determinations if necessary.
